Overview NetSuite™ Bank Feeds Set-up

NetSuite™ is an accounting software package provided by Oracle Corporation. Oracle utilizes Yodlee aggregation services from ENVESTNET.



Clients requiring technical support for NetSuite™ and its data "Banks Feeds" should contact NetSuite directly. Webster Bank only provides the data to the aggregation services provided by ENVESTNET via Yodlee.

Recommended NetSuite™ Set-up Instructions for e-Treasury:

- 1. Since NetSuite is a shared client platform, it is recommended to set up a dedicated user just for accessing account balance and transaction data from e-Treasury.
- 2. Client's should submit a request to their TM Service or Sales Officer to set up a "NETSUITE" user with "Quick View" access and with "password" authentication only.
- 3. After receiving the NETSUITE user credentials and temporary password from Webster Bank, the client should log into e-Treasury (Commercial or Business Banking) and reset the password for this NETSUITE user. (IMPORTANT NOTE: Passwords are only valid for 365 days from creation, so clients will be required to relog into e-Treasury when the password expires and reset it.
- 4. After the NETSUITE e-Treasury user is created and password reset, the client should be ready to link the new user to e-Treasury.
- In Bank Feeds, clients should first disconnect any existing connections to legacy Webster Bank WebLink or Webster Online
- 6. Next, in Bank Feeds, the client should attempt to link their e-Treasury accounts to the appropriate e-Treasury platform, Commercial or Business Banking. (see table above)
- Once the NETSUITE user connects to e-Treasury, the accounts that the user is permissioned too will display
 on the screen to link to NETSUITE. The user should select the accounts to link and the download process
 will commence.
- 8. After the download and linking process is complete, the user can finish setting up the accounts in NetSuite.
